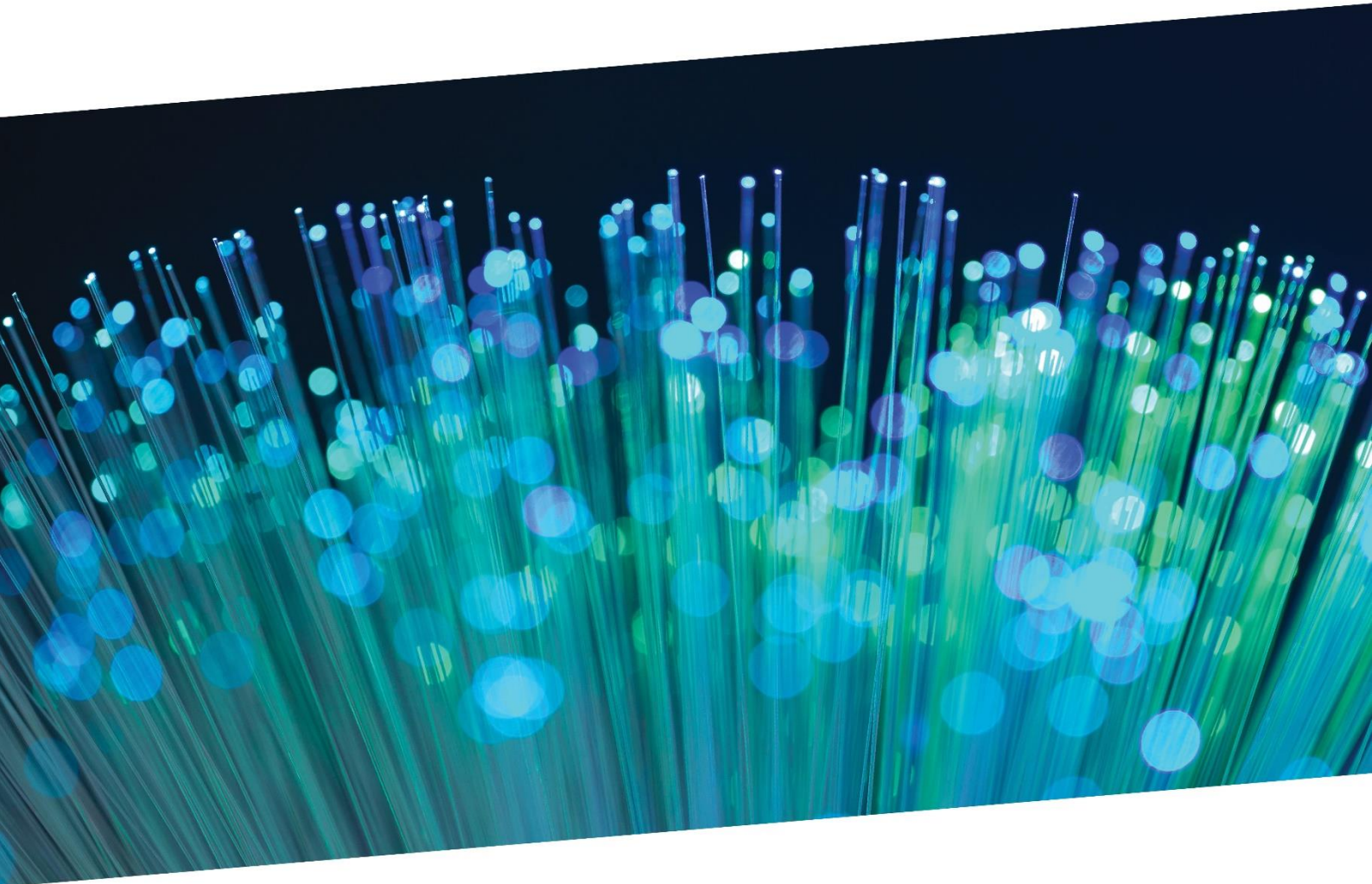

**Venkatachalam Anbumozhi** is Director of Research and Strategy and Innovation at the Economic Research Institute for ASEAN and East Asia (ERIA), Indonesia. His previous positions include Senior Capacity Building Specialist at Asian Development Bank Institute, Assistant Professor at the University of Tokyo, and Senior Policy Researcher at the Institute for Global Environmental Strategies and Assistant Manager in Pacific Consultants International, Tokyo. He has published several books, authored numerous research articles and produced many project reports on energy policies, sustainable infrastructure design, and private sector participation in Green Growth. Anbumozhi was invited as a member of the G20 task force on Green Financing, APEC Expert Panel on Green Growth and the ASEAN Panel for promoting climate-resilient growth. He has taught resource management, International cooperation and Development Finance at the University of Tokyo and has speaking engagements at some of the leading international organizations. He obtained his PhD from the University of Tokyo.



**Jaehan Cho** is a research fellow at the Korea Institute for Industrial Economics and Trade (KIET), the only national research institute in Korea specializing in both domestic and international industry and trade. His research interests include international trade, FDI and international development, global value chains, the strategies of multinational enterprises, and industrial policy. Dr. Cho has served as an associate editor of the Journal of Industrial Economics and Trade, as the co-editor of Future Growth Studies, and as an associate editor of the Journal of International Trade and Industry Studies. Dr. Cho is currently an adjunct professor at Choongnam National University, and he has served as vice-chair on the Committee of Industry, Innovation, and Entrepreneurship at the OECD since 2020. Dr. Cho received his BA and MA in Economics from Korea University before going on to earn an MS and PhD in Economics from Arizona State University



**Chiara Criscuolo** is Head of the Productivity, Innovation and Entrepreneurship Division in the Directorate for Science, Technology and Innovation at the OECD. Mainly, her work focuses on entrepreneurship, enterprise dynamics, productivity and policy evaluation. In this realm, she has coordinated large cross-country microdata projects on employment dynamics, productivity, as well as research and development. Chiara has played a lead role in advancing the use of firm level data and of microdata projects within the OECD. She has contributed to key horizontal and high level projects and publications, including the OECD volumes “Future of Productivity”, “New sources of growth: Knowledge Based capital”, and the “OECD Innovation Strategy”. She co-manages the Global Forum on Productivity is also a member of the French and Portuguese National Productivity Boards. Ahead of joining the OECD, Chiara received her doctoral degree in Economics from University College London and held academic appointments at the University of Siena, City University and the University of Cambridge, in addition to the London School of Economics.



**Dr. Siah Hwee Ang** is Professor of International Business and Strategy and Chair in Business in Asia at the Victoria University of Wellington, New Zealand. Siah is also the Director of New Zealand’s Southeast Asia Centre of Asia-Pacific Excellence. In these roles, he works closely with various stakeholders and companies on their strategies in Asia and Asia’s engagement in New Zealand. Siah’s research is centred around the connection between international business and trade. His works have been published in top-tier international journals and have won several research awards. He is also Senior Editor at the *Journal of World Business*, a leading international business journal. Siah has sat on national assessment panels for the New Zealand Prime Minister’s Scholarships for Asia, the Prime Minister’s Business Scholarships, and the Marsden Fund. Before joining Victoria University of Wellington, Siah was Professor and Associate Dean at the University of Auckland Business School, and worked at City, University of London and NUS, where he completed his doctorate in management. Siah is Visiting Professor at several Asian universities and writes frequently in the media.



**Julia Tijaja** is a trade policy, global value chain, and regional integration specialist. She was Director of ASEAN Integration Monitoring at the ASEAN Secretariat from 2015 to 2021, where she worked on a number of key regional initiatives – among others – ASEAN economic integration monitoring, RCEP negotiations, ASEAN Comprehensive Recovery Framework, ASEAN’s fourth industrial revolution strategy and circular economy framework. She holds a PhD in development economics from the Open University, UK, and an MSc (Economics from Development) from the University of Oxford.
